Angie,

As we have discussed, Sarah Graham and Scott Baker have been identified as good candidates for the positions of Chair and Vice-Chair, respectively, of the Planning Board. The terms of these positions would run from March 2015 until March 2016. A challenge with the terms of these positions is that both Sarah's and Scott's terms on the Planning Board expire this year. Sarah's term expires on September 8 and Scott's on December 31. Both are eligible for appointment to another term. I would suggest that if they are appointed to the positions of Chair and Vice-Chair, that they at the same time be appointed to another term on the Planning Board with their new terms beginning at the expiration of their current terms.
