Description of Duties & Responsibilities:	Responsible for receiving and scheduling transportation service requests, maintaining radio communications with drivers throughout the day, planning and arranging daily trip schedules, managing transit driver work hours. Duties include answering phone, utilizing specific computer software to schedule and dispatch vehicles and drivers. Operation of 2-way radio system to monitor activity and location of drivers and vehicles. Assign drivers and vehicles to fulfill the daily trip schedules. Receive fares and reconcile monies received by drivers to maintain money in a secure manner. Maintain petty cash and receipts for petty cash purchases. Receive mail in office. Maintain and update information pertinent to the Home Community Care Block Grant.
