Meetings take place in Conference Room at the Jackson County Department of Public Health unless otherwise stated.**

The Jackson County Board of Health formulates policies and procedures for the Jackson County Department of Public Health. The Board's authority is established by NC General Statute 135A-35: "The Board of Health shall be the policy making, rule making, and adjudicatory body for a county health department." The Board works with Health Department administrators, clinicians, staff, and our community to protect and promote the public health of Jackson County.
