Subject: FY24 Combined Capital Community Transportation Program Grant Application

The North Carolina Department of Transportation Integrated Mobility Division (IMD) handles grant applications with the Federal Transit Administration for mass and community transportation programs. On behalf of rural communities, the NCDOT IMD completes applications for formula grants for rural areas (Section 5311 Admin) and formula grants for the enhanced mobility of Seniors & Individuals with Disabilities (Section 5310 Operating) as well as capital improvements for transit systems. This allows rural communities to work directly with their state rather than needing to apply directly for funding through the Federal Transit Administration.

Jackson County Transit applied for both 5311 and 5310 funding with the approval from the Board of Commissioners in October 2022. However, due to the recent delay in the State's vehicle contract, the FY24 Combined Capital grant application was postponed to open November 1, 2022.

The Combined Capital program allows Community Transportation (CT) systems the opportunity to apply for funding for capital projects and provides the NCDOT IMD the flexibility to fund the approved projects with the type of funds which best suit the projects and manage the funds in the most efficient and effective manner. The Combined Capital application utilizes funds from the 5311, 5307, 5339 federal programs.

The FY24 Combined Capital Community Transportation Program Grant Application Public Hearing is scheduled for December 20, 2022 at 12:55 pm. As the applicant, Jackson County Transit will be seeking permission to apply for the Public Transportation Program funding with the required local match.
