Dinner for Board Members starts at 6:00 PM with the meeting to commence at 6:30 PM. Meetings take place in Conference Room at the Jackson County Department of Public Health unless otherwise stated.

The Jackson County Board of Health formulates policies and procedures for the Jackson County Department of Public Health. The Board's authority is established by NC General Statute 135A-35: "The Board of Health shall be the policy making, rulemaking, and adjudicatory body for a county health department." The Board works with Health Department administrators, clinicians, staff, and our community to protect and promote the public health of Jackson County.
