 - \$650.50 for Rental Vehicles
 - \$169,481.63 for General Taxes and Interest
 - \$16,766.81 for Landfill Taxes and Interest

- Delinquent Taxes Collected for Jackson County were \$83,439.36
 - \$75,864.69 for General Taxes and Interest
 - \$7,434.11 for Landfill Taxes and Interest

- The total deposited for tax collections for May was \$297,304.32

 - Overpayment Refunds = \$5,287.03
 - Releases = \$995.91
