February 2022

- 2021 Taxes Collected for Jackson County were \$1,365,194.17
 - \$439.57 for Rental Vehicles
 - \$1,279,853.44 for General Taxes and Interest
 - \$84,901.16 for Landfill Taxes and Interest

- Delinquent Taxes Collected for Jackson County were \$63,904.60
 - \$59,829.35 for General Taxes and Interest
 - \$4,068.25 for Landfill Taxes and Interest
 - \$7.00 for Motor Vehicle Taxes and Interest

- The total deposited for tax collections for February was \$1,511,489.83
