 - \$29,182.75 for Landfill Taxes and Interest

- Delinquent Taxes Collected for Jackson County were \$90,499.14
 - \$80,301.89 for General Taxes and Interest
 - \$10,197.25 for Landfill Taxes and Interest

- The total deposited for tax collections for April was \$454,062.38
