Capital Community Transportation Program Grant Applications

The purpose of this memo is to request to hold a public hearing for the FY25 Community Transportation Program Grant Applications on September 19, 2023 at 6:25 pm. One public hearing is acceptable for all three Community Transportation Program Grant Applications. As the applicant, Jackson County Transit will be seeking permission to apply for the Public Transportation Program funding, enter into agreement with the North Carolina Department of Transportation, provide the necessary assurances and the required local match.

The 5311 Administrative grant program helps to subsidize the administrative costs of running a transportation system which includes administrative salaries and benefits as well as office supplies, uniforms, training and marketing.

The 5310 Operating grant program supports transportation operating costs for the elderly and individuals with disabilities.

The Combined Capital grant program allows Community Transportation systems the opportunity to apply for funding to maintain a public transportation system fleet and other capital needs. This capital project consists of three replacement vehicles (one Raised Roof with lift and two minivan /crossover vehicles), lettering and logos for each vehicle, one propane conversion and a 6 camera IP Camera Surveillance System. All vehicles and surveillance equipment are being requested due to having met the end of their useful life and meet the minimum requirements for replacement with NCDOT IMD.
