Staggered 1, 2 and 3-year terms

The terms of the members of the Authority shall be as follows:

One year term: two members from Group One, two members from Group Two and one member from Group Three.

Two year term: two members from Group One, two members from Group Two and one member from Group Four.

Three year term: one member from Group One, one member from Group Two, one member from Group Five.

Thereafter, all terms shall be for three years. Reappointment to the Authority shall be limited to two consecutive terms with eligibility for another reappointment after sitting out for one year.

9-member board

Chairman appointed each year by Commissioners, BOC does not have to approve the vice chair
