Position:	Public Health Nurse II <i>Permanent, Full Time, Exempt</i>
Department:	Health Department
Description of Duties & Responsibilities:	This is an intermediate level public health nursing position, providing care to individuals and families in Public Health programs. This position will serve as a part of a team and/or charge nurse in clinics and will have responsibility of coordination in at least one clinic/program. Clinic programs include Women's Health, Adult Health, STD/HIV, Communicable Disease/TB, Children and Adult Immunizations, General Clinic, etc. Duties also include working in a variety of clinics completing medical histories, providing prescribed treatments and immunizations as needed, and other duties as required/ May also be responsible for occasional community outreach in Jackson County. Required to participate in preparedness exercises/event at times. Reports to the Nursing Director. All RNs are encouraged to apply.
Education & Experience Requirements:	Graduation from a four-year college or university with a B.S. in Nursing which includes a Public Health Nursing rotation and one year of Public Health Nursing experience; or Master's in Public Health and graduation from a school of professional nursing and one year of professional nursing experience; or graduation from a school of professional nursing and two years of professional nursing experience including one year of Public Health Nursing experience; or an equivalent combination of training and experience. Possess and maintain a valid NC driver's license. A current license to practice as a Registered Nurse in North Carolina by the NC Board of Nursing. Trainee and Work Against Applications will be accepted.
Starting Salary:	Grade 26 - Salary Range (\$44,207.18 - \$64,401.51) and will be commensurate with experience. Nursing experience to include hospital, private practice, etc. will be considered.
