Purpose

The purpose of the Municipal Grant Program is to assist the municipalities of the county with the implementation of worthy projects that will directly benefit not only the citizens of the municipality, but all the citizens of Jackson County.

Calendar

Applications for the Municipal Grant Program will be accepted until 5:00 pm on January 7, 2022. The Board of Commissioners will review the applications during the January work session and grant awards will be announced at the January mid-month meeting. Grant funds will be available after award.

Grant Amount Available

\$20,000 has been earmarked for the Municipal Grant Program. Individual grant requests are limited to a maximum of \$5,000 per municipality.

Project Name: Park Equipment for JC BOE Site

Project Description: Thank you for offering the municipal grant opportunity again. We are grateful for the opportunity to work together to make our communities better places to live, recreate, and congregate. The Town of Webster would like to apply for a grant this year to purchase additional picnic tables and benches to be placed on the Jackson County Board of Education property of approximately one acre that surrounds the school's softball field, which is adjacent to Southwestern Child Development Center located at 1528 Webster Road. Use of these picnic tables and benches will in no way limit, or detract from the current use of the softball field property, and may be used by Jackson County for school functions, by visitors, and by residents of the town and the county.

Previous discussions with JC Recreation and Parks Department, and the Board of Education have resulted in possible future plans for a small park at the site. The proposed new park equipment will match the four previously purchased picnic tables, and at least half of them will be ADA accessible. All tables purchased and placed on the property may be relocated when necessary as park planning progresses.

A community need for a safe, outdoor meeting place has been determined through three previous Webster community surveys. The need for gathering places that allow for physical distancing for community members has been exacerbated by COVID-19, and has become even more important for fostering social connection during the ongoing Coronavirus pandemic.
