Subject: Cashiers Community Collaborative/Update to Commissioners

Hi Don, thanks for your time this morning to discuss Glenn Ubertino (President/Cashiers Area Chamber Board, Chair/Cashiers Area Community Planning Council, and Chair/Cashiers Community Collaborative) and me to present very briefly (10 minutes) to the Board of Commissioners at an upcoming work session. Our intent, since the release of the

report in early June, has been to express our gratitude in that forum for the County's support of the ULI panel visit and to describe next steps in community implementation of select priority recommendations.

As you'll see in the attached announcement and last month's meeting agenda, the mission of the group is to gain efficiencies and effectiveness through group collaboration and to be unified in our funding requests to government and private sources. The list of invited participants below can certainly be expanded to include any other major stakeholder groups. It was composed thus far of organizations who could leverage resources as well as their constituent lists for communications, volunteerism and financing.

In our initial meeting in August, the CCC participants agreed to the concept of coordination and leadership aligned with the Functions and Roles identified in the ULI matrix (report page 28). The long-term conservation plan was agreed upon as a sequential priority under the "championship" of Dr. Gary Wein, of the Highlands Cashiers Land Trust, and Dr. Bill Horton, of Develop Cashiers Responsibly and Village Green.

I've reached out to Glenn to see if he would like to come on 11/7th as a courtesy visit to the current Board of Commissioners, understanding that regardless of the outcome of the election, we'd like to return periodically to provide an update on CCC efforts. As usual, we will also stay in close contact with Commissioner Mark Jones.

I will report back to you as soon as possible.



NEW! CASHIERS COMMUNITY COLLABORATIVE

As sponsor of the ULI Advisory Services growth management analysis, the Cashiers Area Chamber will continue its leadership commitment to inclusivity and transparency through select implementation of the ULI Panel's recommendations.

At the chamber's invitation, representatives of the Cashiers Area Community Planning Council, Chamber Board, Cashiers Historical Society, Highlands Cashiers Land Trust, Develop Cashiers Responsibly, and Vision Cashiers recently met to discuss next steps as recommended in the Panel's final report. ULI suggested specific functions and roles for community organizations in Cashiers (see matrix on page 28 of the printed report available at www.CashiersAreaChamber.com "ULI Updates").

This goal of the first "Cashiers Community Collaborative" organizational meeting held on June 28th was to confirm these stakeholder champions' commitment to a coordinated approach to community projects and funding. The group agreed that discipline will be needed to ensure that collective efforts and resources are leveraged as efficiently as possible.

Priorities will be established so that financial and other assistance from local, state and federal governments and other funding sources will be solicited in a unified manner to avoid parochial competition. Other stakeholders and supporters will be invited to participate in the initiative as plan details develop.

One of the major functions recommended by ULI is creation of a nonprofit community development corporation to identify and manage funding options for the purchase and lease of diverse products in an expanded housing market. The ULI said building attainable housing and promoting mixed-use development will help address critical workforce needs, which they called "an existential crisis for Cashiers' small businesses and institutions." Research is now underway to determine the best structure for the 501(c)3 nonprofit and to recruit an experienced expert to establish initial operations and sustainable systems.

In its report, the ULI Panel recognized that Cashiers is a "special place" and the opportunity and challenges ahead are to grow either by default or by design. The Cashiers Community Collaborative participants will work with other stakeholders in the future to ensure we address inevitable growth with proactive strategies that, as the ULI Panel advises, "ensures the qualities that have made Cashiers special will not be diminished."

Periodic updates on the Collaborative's work will be shared publicly via email, media outlets, and presented at monthly Cashiers planning council meetings typically held on the fourth Monday, 5:00 p.m. at the Albert Carlton Cashiers

Community Library. For more information, see Jackson County Planning Department jacksonnc.org.
