

# Budget Request 2025-2026 School Year

## LOOKING AHEAD.....

## JCPS 2025-2026 GOALS

- Increase monetary support for continued CEP-No cost Lunches
- A maximum of 4% increase for all staff
- Continue 6 Student support positions funded through the County Commissioners
- HVAC & Fire alarm system (est. \$500,000) for Jackson Community School
- Increase local supplements:
  - 325 Certified positions to \$2500
  - 250 Non-certified to \$1500

# JROTC-Reserve Officers' Training Corps

#### 2024 Establishing Cost

- Personnel Costs- January- June \$119,935
- Army MIPs reimbursement \$7337 per month Approximately \$44,022 for January-June.
- Total Costs to the District of \$75,913
- Equipment & Supplies \$6,542



#### Reoccurring Program Costs

- Projected Personnel Costs for 11 months-\$233,904
- Projected Army MIPs reimbursement \$8,000 Approximately \$88,000 August-June
- Total Cost to the District of \$145,904
- Anticipated program costs **\$75,000**



## **2025-2026 REQUESTS**

#### We are asking our County Commissioners to support our goals by:

- Provide complete funding for locally paid employees' salary increases
  - Maximum 4% increase for staff salaries
  - Historically, JCPS did not ask for an increase in funding for the NC General Assembly's mandated 2021-2022 non-certified staff salary increase to \$13 per hour minimum, or the mandated 2022-2023 state non-certified staff salary increase to \$15 per hour minimum
  - JCPS received a 2% increase from Jackson County in 2024-2025; however, the state mandated a 3% raise for all non-certified support staff
  - We implemented and decompressed salaries of non-certified personnel beginning in 2022
  - Benefit rate changes that impact locally paid staff
- Provide funding for mandates that impact the local budget by exceeding state allotments (non-certified support staff)
- Provide funding for any state bonuses for locally paid staff
- Provide funding for local supplement increases for both Certified & Non-certified staff
- Funding for JROTC Program
- Funding to continue No Cost Meals

# Budget at a Glance

There are two major components of our Budget:

**Operating Budget** 

Primary sources of funding are state, federal, grants, and **county tax dollars** 

#### Day-to-day operating costs

- Salaries and benefits
- Purchased services-(Substitutes, Legal, Audit, Leases)
- Professional Development
- Supplies and materials
- Maintenance
- Transportation
- Utilities.
- Liability & WC Insurance

**Capital Budget-School** 

Primary sources of funding are sales tax articles 40 (40%) and 42 (60%)







# Charter Schools (G.S 115C-218.105)

- Receive a prorated portion of our County Commissioner allotment
- This portion is based on their enrollment
- ~ \$1,000,000 of our allotment will be paid to Charter Schools in 2025
- Charters are eligible to receive State & Federal Funds directly
- Charter are eligible to apply for grant funding
- Sessions Law 2021-79 section 1 rewrote GS 115C-218.105 in August 2023
