Project Name: Main St. & Mill St. Sidewalk Connection
Project Description: The Town of Sylva is requesting the Jackson County Municipal grant funding to extend the sidewalk on the north side of Main Street to the crosswalk at the intersection of Main Street and Mill Street. The proposed sidewalk would have both curb and gutter. The total project cost is \$6,900, so the town is requesting \$5,000 to fund the project. Pedestrians currently walk along the north side of the street if travelling from Main Street to Mill Street even though there is existing sidewalk along the south side of Main Street. This proposed sidewalk connection is more important now that vacant properties at the end of Main Street are filling up with new businesses. This proposed sidewalk will make it easier to walk to these destinations. The sidewalk on the north side of Main Street would be extended to the east to fill the gap along Main Street. The sidewalk would be made handicap accessible for

pedestrians. The attached photos and PDF show the current and proposed location of the sidewalk.

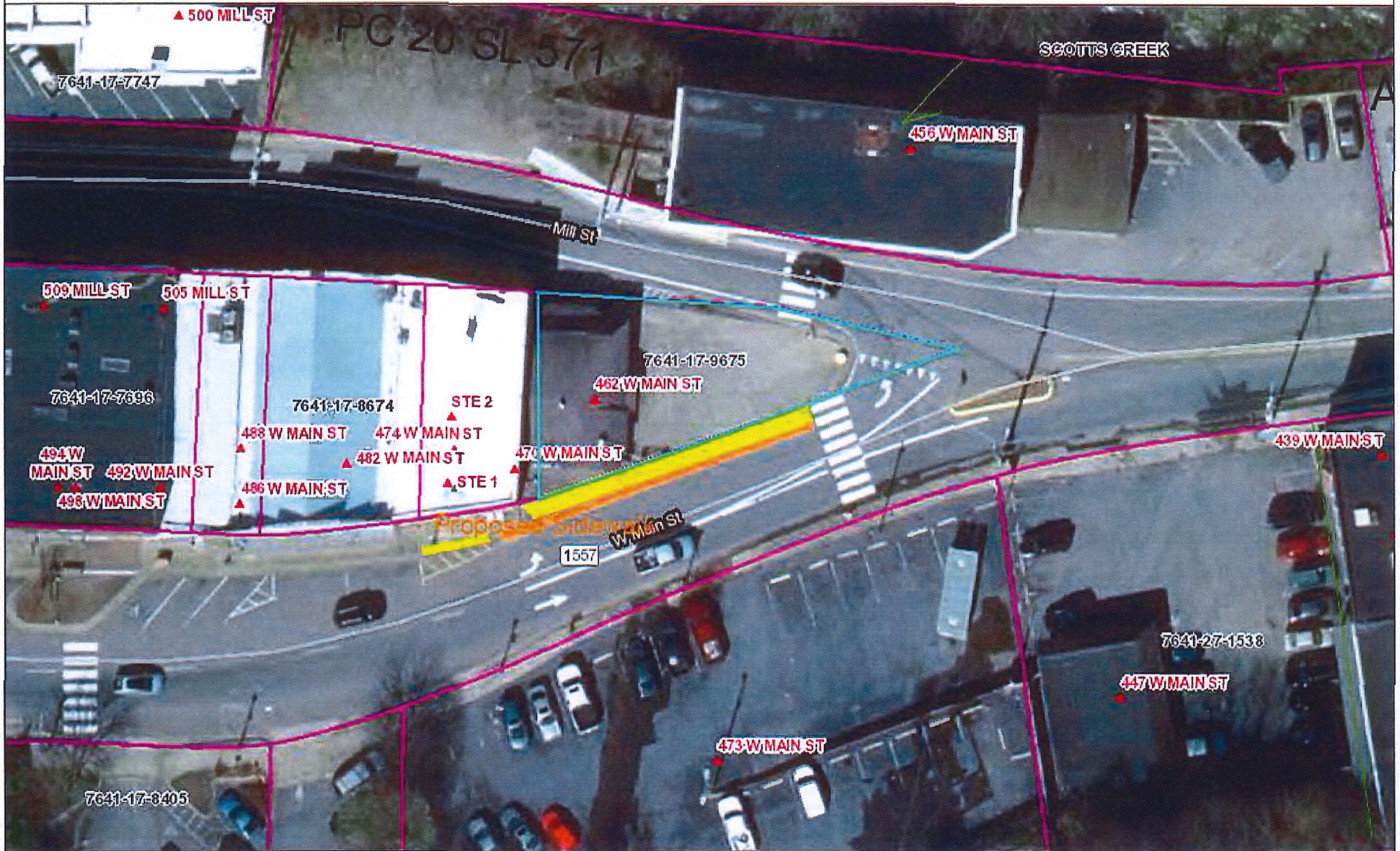

Project Name: Picnic Tables for Community Gathering

Project Description:

The Town of Webster would like to apply for a grant to purchase picnic tables to be placed on the Jackson County Board of Education property of approximately one acre that surrounds the school's softball field, which is adjacent to Southwestern Child Development Center at 1528 Webster Road. This project is contingent upon development and adoption of a Memorandum of Understanding (MOU) between the Town of Webster and the Jackson County Board of Education. Use of these picnic tables will in no way limit, or detract from the current and infrequent use of the softball field property.

A community need for a safe, outdoor meeting place has been determined through previous Webster community surveys. The need for gathering places that allow for physical distancing for community members has been exacerbated by COVID-19, and has become even more important for fostering social connection during the Coronavirus pandemic.

These tables could be used by town residents, families whose children attend the Southwestern Child Development Center, other county residents, and for Jackson County School functions. Previous discussions with JC Recreation and Parks Department have resulted in possible future plans for a small park at the site. Any tables purchased and placed on the property may be relocated when necessary as park planning progresses. At least one table will comply with ADA accessibility standards.



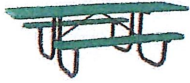

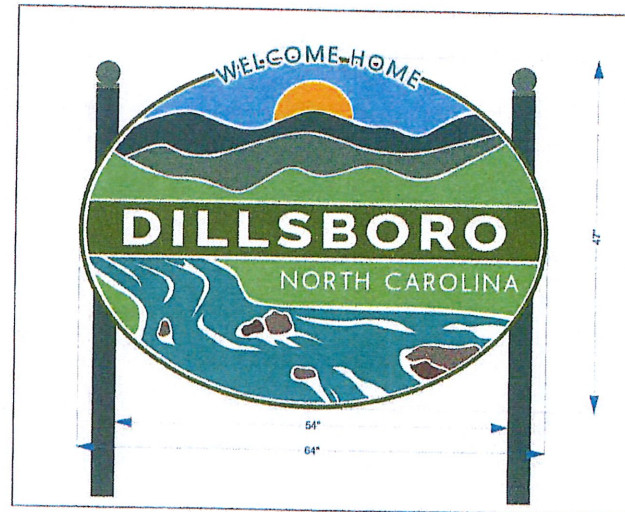
