Jackson County Board of Commissioners,

On behalf of the Jackson County Tourism Development Authority, it is my pleasure to share our recommendations with you for upcoming seats on the TDA.

For the unexpired seat expiring 12/2/2022 previously held by Kathy Korb of Laurelwood Inn, we would ask for **Daniel Fletcher**, co-owner of Hotel Cashiers (formerly Cashiers Village Inn) to be appointed to that seat.

For the seat expiring 12/2/2020 held by Andrew Harlfinger of Bluegreen Vacations, we would ask for **Craig Smith**, of Bear Lake Reserve & BLR Vacation rentals to be appointed to that seat.

For the seat held by Brad Herman, expiring 12/2/2020, he has agreed to resign to allow for High Hampton Resort's new General Manager, **Scott Greene**, to fill that role on behalf of the organization. We have been planning for this transition over the last year.

We have vetted these new appointments and are very impressed with the expertise, experience, and leadership they will bring to our organization and further the goals of our TDA and help boost the economy in Jackson County.

For the seat held by **Dale Collins**, expiring 12/4/2020, we would ask that Mr. Collins be **reappointed**.

We would ask commissioners to appoint **Robert Jumper to the Chairman** role. In consultation with current Chair, Ann Self, whom we plan to name vice-chair, this move will provide good succession planning. It will also provide a very strong leadership team for the JCTDA.

We also need a **Commissioner Appointment** to Mr. Ron Mau's Ex-Offico seat as well. We have developed onboarding for new board members, and will schedule a time to meet with the new appointee to get them upto-date.
