On behalf of the Southwestern Child Development Commission Board of Directors, I would like to respectfully request that Dr. Kimberly Elliott be reappointed to our Board of Directors as a Jackson County Representative.

Dr. Elliott retired as Superintendent of the Jackson County Public Schools on September 1, 2020. Dr. Elliott brought excellent knowledge and experience to our Board, as a part of her professional work. As she will be continuing in Educational Consulting, she will continue to be a valuable member of our Board. Dr. Elliott's passion for Early Childhood Education is a special knowledge and skill that we value. Knowing what Jackson County young children need to know to be successful in school will offer her the opportunity to help guide decisions that our agency makes each day.

At this same time, I would like to request that Jennifer Abshire, Department of Social Services Director, be confirmed as a Jackson County Representative to the Southwestern Child Development Board of Directors. When Jennifer transitioned to the Director's Position, upon the retirement of Robert Cochran, she also transitioned to his Board Seat, as is customary in each of our seven counties in Region A. However, in reviewing our Board documents, we should have asked for a letter from Jackson County supporting that change.

Southwestern is a private not-for-profit board with a 501(c)3 organizational status. Our Board meets one time per quarter and we move those meetings among the seven western counties in Region A. Our Board Members are from a variety of backgrounds, each representing an area of expertise in early childhood education. Our agency has operated in Region A since 1972, or for the past 48 years. In each county in Region A, (Cherokee, Clay, Graham, Haywood, Jackson, Macon and Swain County) the County Commissioners appoint three Board Members to our Area Board of Directors.
