## MINUTES OF A WORK SESSION OF THE JACKSON COUNTY BOARD OF COMMISSIONERS HELD ON APRIL 01, 2025

The Jackson County Board of Commissioners met in a Work Session on April 01, 2025, 6:30 p.m., Justice and Administration Building, Room A201, 401 Grindstaff Cove Road, Sylva, North Carolina.

Chairman Letson called the meeting to order.

(1) <u>MOUNTAIN PROJECTS</u>: Patsy Davis, Executive Director and Si Simmons, Deputy Director, were present for this item.

Ms. Davis presented: Housing Choice Voucher Program:

- (a) Housing Choice Voucher (HCV) Program:
  - Help for low-income families, seniors and individuals with disabilities afford safe, private market housing.
  - Administered by Public Housing Agencies, it provided rental assistance by covering a portion of the rent, with families paying the rest.
  - Promote housing stability and choice for participants
- (b) HCV Rental payments January 2022-March 2025
- (c) Vouchers in use per unit
  - January 2022 Voucher in use 842: \$466.60 per unit cost
  - March 2025 Voucher in use 889: \$746.06 per unit cost
- (d) Shortfall:
  - In August, 2024, Mountain Projects, Inc. was notified by HUD that it was entering shortfall status, halting new voucher issuance due to projected overspending.
  - HUD and HCV consultants indicated entering shortfall was necessary to secure additional funding and expand the program long term.
  - Maximizing voucher use had been a challenge due to landlords leaving the program for the more lucrative private and vacation rental markets.
  - Fair Market Rents set by HUD often fall below actual market rates, but in 2023 and 2024, Mountain Projects received approval from HUD to raise rent standards to 120%, making vouchers more competitive.
  - HUD based funding on prior year spending, leaving Mountain Projects underfunded in 2024 despite increased voucher usage.
  - A nationwide shortfall in HUD's set aside funds delayed additional funding and with congressional stop gap funding stuck at 2024 levels, Mountain Projects would likely remain in shortfall through 2025, unable to issue new vouchers to assist the 500+ families on the waiting list.

- (e) HCV Waitlist:
  - 552 total applicants
  - 415 Haywood County applicants
  - 137 Jackson County applicants
  - 247 days average wait time
- (f) Volume of continued need:
  - Jackson County office received approximately 10-15 phone calls each week from families in need of rental assistance
  - Haywood County office received approximately 25-30 phone calls each week from families in need of rental assistance
- (g) Conclusion and next steps:
  - Demand for vouchers remain high, especially in the wake of Tropical Storm Fred, Hurricane Helene and the closure of the Canton paper mill
  - Mountain Projects remained in shortfall despite contacting representatives and appealing to HUD directly
  - Without sufficient funding, Mountain Projects could not provide critical support leaving the most vulnerable at risk

(2) <u>LIBRARY REPORT</u>: Tracy Fitzmaurice, Librarian, presented: Albert Carlton-Cashiers Community Library and Jackson County Public Library:

(3) <u>AMERICA 250 COMMITTEE</u>: Mr. King stated the Board previously passed a resolution to establish the 250 Committee, which was created to plan, encourage, develop and coordinate the commemoration of the 250<sup>th</sup> anniversary of the United States. Staff would look to publicize an ad seeking volunteers for membership. He would recommend appointing seven to nine individuals to the committee.

He recommended the volunteers selected for the America 250 Committee also serve on the Jackson 175 Committee for the county anniversary coming up in 2026. The county received a grant of \$10,000 to be used for marketing and events for the America 250 Committee.

<u>Consensus</u>: Staff to move forward with publicizing for membership on the America 250 Committee / Jackson 175 Committee for seven individuals.
