MINUTES OF A REGULAR MEETING OF THE JACKSON COUNTY BOARD OF COMMISSIONERS HELD ON JUNE 03, 2025

The Jackson County Board of Commissioners met in a Regular Session on June 03, 2025, 6:07 p.m., Southwestern Community College, Balsam Center, Myers Auditorium, 447 College Drive, Sylva, North Carolina.

Chairman Letson called the meeting to order.

(1) <u>AGENDA</u>: Chairman Letson requested to amend the agenda by moving New Business before Informal Comments by Public. Commissioner Bryson moved to approve the amended agenda. Commissioner Smith seconded the Motion. Motion carried.

- (2) <u>MINUTES</u>: Commissioner Bryson moved to approve the minutes of a Regular Meeting of May 20, 2025, as presented. Commissioner Jennings seconded the Motion. Motion carried.
- (3) <u>CHAIRMAN'S REPORT</u>: Chairman Letson stated he joined Mayor Phillips at Mark Watson Park for a Memorial Day Ceremony. It was a wonderful service and he encouraged everyone to attend in the future.

(4) COMMISSIONER REPORTS:

(a) Commissioner Jennings stated there were a lot of rumors floating around that were not true. Before public comment, he wanted everyone to know that no one on the Board was for closing libraries or banning any books. They were simply trying to get certain books moved to a different section.

Freedom of speech was very important and he believed in it for adults, not so much for kids because people could write books about anything. He did not believe kids should be reading anything and everything. Someone could write a book entitled how to shoot up a school or the benefits of illegal drugs. Kids should not read those books or some of the books at the library now that gave step by step instructions how to solicit sex from adults. It was not just immoral, it was illegal.

Movies were even rated PG13 or R. If a child could not see certain movies, why was it right for them to read about something more graphic than what they would see in a movie. The Board had asked FRL to make these changes in these areas and so far, they had not seen any. If they would come their way on the books he was referring to, they may get to a compromise quicker. Unless something changed, he supported leaving FRL.

(b) Commissioner Bryson stated he was not for closing a library. He he never received one phone call from the Sylva Herald about how he stood on the issue. To set the record straight, he was not for closing the library. It was never an issue. It got blown out of proportion by the media.

- (7) **BOARD OF ELECTIONS REPORT**: Amanda Allen, Board of Elections Director, presented:
- (a) Mission: Conducting safe, secure, fair and impartial elections for the people of Jackson County. Effective processes//proactive planning//multi-partisan, community-led efforts.
 - **(b)** Who we are and what we do:
 - The Board of Elections (BOE) was a state mandated county department.
 - Governed by five appointed, multi-partisan board members.
 - Board appointed Director oversees day-to-day operations and election administration.
 - Bound by local, state and federal election laws and rules from the State Board of Elections (SBE).
 - County government's role was largely budgetary.
 - One to three elections held every year, but election functions occurred daily.
 - (c) Key Election Tasks:
 - Candidacy: All candidate filing was done at the BOE, including petitions.
 - Campaign Finance: All campaigns must follow campaign finance law, often locally administered.
 - Program and Test: Voting equipment was tested and uniquely programmed prior to each election.
 - Poll Workers: Recruit, train and deploy 150+ precinct workers; 50+ new workers in 2024.
 - Ballot Processing: In-person (Early and Election Day), Absentee-By-Mail and Provisional.
 - Administer Election: Included 1-5 Early Voting sites and 13 Election Day precincts. Plus, processing any challenges or protests.
 - (d) Year-Round Tasks:
 - Voter Registration
 - List Maintenance: Daily, weekly, monthly, annual, biannual functions
 - Mapping: Collaboration with local, tribal and state GIS.
 - Media and Public Engagement

- Public Records Requests
- Campaign Finance: Reports throughout the year, plus audits.
- Petition Processing: Local and state level.
- Training/Conferences: Mandated for Board and Director, at a minimum.
- (e) Always Preparing for the Next Election:
 - After Action Analysis: With precinct workers, staff, board, stakeholders
 - Scheduling and checklists
 - Jurisdictional Audits
 - Emergency and Security Planning: 2024 advances included cameras and access controls.
 - Voting Equipment Maintenance: Performed annually by PrintElect.
 - Coordinating Voting Sites
 - Supply inventory/ordering
 - Forecasting staffing: Recruitment and retention
 - Preparing for changes
