Jackson County Board of Commissioners,

On behalf of the Jackson County Tourism Development Authority, it is my pleasure to share our recommendations with you for upcoming seats on the TDA.

For the seat expiring 12/2/2019 held by Kathy Korb of Laurelwood Inn, we would ask for her reappointment to another term.

For the seat expiring 12/2/2019 held by Megan Orr of Nightstar Lodging, we would ask for her reappointment for another term.

For the seat expiring 12/2/2019 held by Bob Williams of Dillsboro Chocolate Factory, we would recommend a new individual for that seat. Mr. Williams will spend a significant amount of time chairing a new committee as part of implementing our Strategic Plan initiatives. We have spoken with Mr. Williams, and he is in favor of this transition to Chair this crucial initiative.

We would ask commissioners to appoint Robert Jumper to that at-large seat. Mr. Jumper, who previously served as Chair of the TDA and longtime board member, is now eligible for reappointment having been off the board the requisite time. He will bring not only a great historical perspective, steady leadership, but continuity as we look at future succession planning with our board.

Ms. Laura Bowers, who has served on our board since 2017 has accepted a position with her company in another state, so we need to fill that unexpired term. For that term expiring 12/2/2020, we would recommend Anna Thomas, General Manager of Comfort Inn of Sylva. Ms. Thomas has expressed a keen interest and desire to serve to further our goals, and we would welcome her contributions.

For the annual Chair seat we would request Mrs. Ann Self who has provided steady and strategic leadership continue in that role.
